Get them to prove their worth by having them evaluated by TIPES. If it works, TIPES will find out.

WHAT IS TIPES?

TIPES is a process that provides an independent fit-forpurpose assessment of innovative road products and new technologies. Products that fall outside the scope of established standards and specifications can be tested, trialled and proven to be reliable and safe.

TIPES IS FOR ALL ROAD AGENCIES

TIPES is a safe and reliable point of reference, as well as a standardisation of processes administered by one independent body.

The aim of TIPES is to establish a national process for the Australian road industry to follow when adopting new technology and innovative approaches. By doing this we can create a pool of approved products for all road agencies to use.

- One-stop-shop for creating consistency for all.
- Alleviates uncertainty when using new technologies.
- Helps create a pool of approved products for the road industry to use.
- Lessons from past trials across local government and state road agencies can be captured and shared nationally.



TRANSPORT INFRASTRUCTURE PRODUCT EVALUATION SCHEME (TIPES)

HOW TIPES WORKS

Products will be assessed by an expert panel (inclusive of road agency representatives), who will determine what is required to substantiate the proponent's claims for the product. This will involve products being evaluated through a gating process (where products need to pass each stage to move to the next phase of evaluation). These stages are:

STAGE 1



EVALUATION

An evaluation of available product information. This evaluation will be at the product owners cost.

STAGE 2



TEST

An independent series of laboratory tests.
This evaluation will be at the product owners cost.

STAGE 3



TRIAL

Field trials will be undertaken to assess real-world performance. It is envisaged that to reduce costs trials may be incorporated into existing road authority / local government projects, with extra costs for the trial borne by the product owner.



WHO IS USING TIPES?

TIPES is a national scheme endorsed by all Australian State and Territory road agencies as well as Queensland Local Roads Alliance, Western Australian Local Government Association (WALGA) and IPWEA QLD.

WHAT DO YOU NEED TO DO?

Request a TIPES certificate of registration from the proponent of a product as a condition of use/purchase/trial, where:

- 1. A new or substantially modified product is being considered for use.
- 2. A product in existing use will be used in a completely new or innovative way.
- 3. The product has not already been evaluated for a particular application consistent with TIPES.
